Subj: Non-payment of Deputation (Duty) Allowa ce to Mizoram State Govt. Employees deputed to ex-cadre pests and outside the normal field of deployment.

The undersigned is directed to draw atter ion of all concerned authorities to para 3(i) of O.M.No.A.35011/1/1988-P&AR (GSW) dt 05.03.1990 regarding instructions on grant of Deputation (Duty) Allowance.

- 2. It is hereby reiterated that in all cases of transfer/posting under the Government of Mizoram from one department/bc dy/agency, to another department/body/agency neither Deputation (Duty) A lowance is admissible nor exercise of option is allowed. Such Government ervants on deputation will draw their grade pay in the parent cadre with ut Deputation (Duty) Allowance even if the deputation posts carry high r pay scale, but can exercise the financial/administrative statutory power vested in the regular incumbents, as the case may be.
- 3. The above decision at para 2, however, shall continue to exclude Govt. servants deputed to posts envisaged in para 3(ii) issued under O.M.No.A.35011/1/1988-P&AR(GSW) dated 05.03.1990 and O.M.No. A.35013/1/91-P&AR (GSW) dated 07.10.1991.
- 4. All Administrative Departments and A 1 Heads of Department are further requested to follow existing provision of Rule 3 specified in the Schedule XXV of the Govt. of Mizoram (Allocat on of Business) Rules, 1987 for submission of cases of deputation and to trictly comply with the content of this Memorandum.

Transfer on deputation/foreign service of Central Government Employees to ex-cadre posts under the Central Government /State Governments / Public Sector Undertakings/Autonomous Bodies, Universities/UT Administration, Local Bodies etc. and vice-versa-Regulation of pay, Deputation (duty) Allowance, tenure of deputation/foreign service and other terms and conditions-regarding.

The undersigned is directed to convey the sanction of the Governor of Mizoram to payment of revised rate of Deputation (Duty) Allowances to the employees of the Government of Mizoram on the implementation of the Mizoram (RoP) Rules, 2010 on the analogy and umbrella, however with certain modifications of the recommendations of the 6th CPC on the following conditions and provisions under para 6.1 of O.M. issued by the Central Government vide No.6/8/2009-Estt.(Pay II) dated 17.6.2010.

- Deputation (Duty) Allowances will continued to be paid in case of appointments made in public interest outside the normal field of deployment as curtailed in the DP&AR(GSW) OM No.A.35011/1/2008-P&AR(GSW) dt.19.8.2010.
- 2. In cases of deputation within the same station, the allowances will be paid at the rate of 5% of basic pay subject to a maximum of ₹2000 p.m.

- 3. In other cases Deputation (Duty) Allowances/Special Duty Allowance will be payable at the rate of 10% of the employees basic pay subject to a maximum of ₹ 4000/- p.m.
- 4. The Deputation (Duty) Allowances as above shall further be restricted as under:-

Basic pay, from time to time, plus Deputation (Duty) Allowances shall not exceed the maximum of the pay band PB-4 (₹ 67000) plus the grade pay of the post held on deputation in case the Grade Pay of the post held on deputation is upto ₹ 10000. In case the post held on deputation is in the HAG or HAG+ pay scales, the Basic Pay, from time to time, plus Deputation (Duty) Allowances should not exceed ₹ 79000 and ₹ 80000 respectively.

Note: Basic Pay in the revised pay structure means the pay drawn in

Note: 1 The term same station for the purpose will be determined with reference to the station where the person was on duty before proceeding on deputation.

Note: 2 Where there is no change in the headquarters with reference to the last post held, the transfer should be treated as within the same station and when there is change in headquarters it would be treated as not in same station. So far as places falling within the same urban agglomeration of the old headquarters are concerned, they would be treated as transfer with the same station.

The rate of Deputation(Duty) Allowances as above shall take effect from 1.9.2011.
